



Adoption Forms for Cats and Kittens

Please Fill Out Applicable Forms **COMPLETELY**

NOTE: If you don't have access to a printer please email ourlastdaydogs@gmail.com to have adoption forms mailed to you. 2 copies of each form **MUST be filled out at the time of adoption. 1 copy for the adopter and 1 copy to be mail into LDDR within 3 days of the adoption.**

PLEASE go over each form with the adopter and make sure they understand what they are signing and what's expected of them. 2 especially important areas are:

- Adoption Contract: Bullet 2 which states the adopter is not to rehome the cat, they **MUST** contact LDDR & Bullet 3 the cat is NOT to be declawed
- Sterilization Agreement: Make sure the adopter understands they **MUST** send in proof of sterilization to LDDR within 14 days of the SA Due Date

Adoption Contract –

- Used for **ALL** cats/kittens
- LDDR no longer accepts cash for the adoption fee
- Mark (top right on page) whether the foster being adopted is a “cat”, “cat-mother” or “kitten”
- Bullet 2 – adopter **MUST** initial, \$1000 penalty will be incurred if cat is rehomed without LDDR's involvement/permission
- Bullet 9 – adopter **MUST** initial (Schedule A is now **REQUIRED** for **ALL** adopters)
- Bullet 10 – **NEW** info in microchip: place microchip label or write microchip number on the space provided

Schedule A –

- Used for **ALL** cats/kittens
- All adopters **MUST** sign Schedule A even if there are no children currently living in the household

Medical/Behavior Addendum A –

- Great form to give the adopters specific information on your foster
 - Food foster is currently eating
 - Behaviors that need work or are currently being worked on
 - Habits/Routine
 - Vetting due in future (vaccines, deworming, tests, etc.)

Sterilization Agreement –

- **MUST BE FILLED OUT** for any cat/kitten that is being adopted out **BEFORE** being spayed/neutered
- Adopter **MUST** pay an additional \$25.00 deposit
- Set “Due Date” for when the kitten will be roughly 6 months old (**DO NOT** put “6 months old” – you **MUST** put an actual date)
- **ALL** cats over 6 months of age **MUST** be spayed/neutered **BEFORE** adoption unless it is determined by a veterinarian and the LDDR Board that it is medically unsafe to do so
- For adult cats set “Due Date” for when the cat will be healthy enough to be spayed/neutered
- Adopter **MUST INITIAL** whether they want the deposit “refunded” or “donated”
- Adopter's now have 14 days (instead of 7 days) to send in proof of spay/neuter
- \$1000 penalty for not spaying/neutering unless a vet says it needs to be delayed due to health reason (if that happens – adopter **MUST** send in a letter from the vet)

Kitten Addendum –

- Used for kittens under 6 months of age
- If you (or another LDDR volunteer) are giving the kitten/kittens the vaccines – you **MUST** peel off the stickers from the vaccine vials and place them on this form next to the appropriate vaccine (2 labels)

Trial Adoption –

This form is **ONLY** to be filled out with an LDDR Board Member's permission

ADOPTION – CONTRACT, RELEASE AND SCHEDULE A FELINE

Last Day Dog Rescue, Inc. (Last Day), in consideration of the sum of _____, the receipt of which is hereby acknowledged, releases the full responsibility and ownership of _____ (the "Rescue Cat") _____ (LDDR Rescue ID) to the undersigned Adopter. The adopter agrees to abide by the terms and conditions of adoption as follows (the "Agreement"):

- 1. Indemnification and Hold Harmless.** The undersigned Adopter hereby agrees to release, indemnify, and covenant to hold harmless Last Day, its officers, members, agents and other representatives, from any claims, damages, injuries, costs or actions incurred as a result of this adoption or caused by the actions of the Rescue Cat.
- 2. Transfer of Ownership.** ****INITIAL HERE: _____**** The Adopter will NOT transfer ownership of the Rescue Cat to any other person, shelter, boarding/kennel or humane society. **If for any reason the adoption is not satisfactory, the Rescue Cat will be returned to Last Day (Note: there will be no refund if the Rescue Cat is returned).** If returning the Rescue Cat, the Adopter must allow Last Day up to 10 business days to find placement for the Rescue Cat into a new living situation. The Adopter agrees to notify Last Day with his or her new address upon moving and to notify Last Day if the Rescue Cat is lost or stolen. Transferring ownership of the Rescue Cat to a new permanent address without Last Day's involvement/permission will incur a penalty of \$1000.00.
- 3. Health.** The Rescue Cat will be placed on a yearly inoculation and parasite check program as prescribed by a licensed veterinarian in order to assure/maintain the health of the Rescue Cat. The Rescue Cat will receive a rabies vaccination (either 1 year or 3 year) and will be tested for feline leukemia by a licensed veterinarian. If the Rescue Cat is not sterilized upon adoption, a separate spay/neuter contract will be completed which will specify the date by which the Adopter will have to submit proof (copy of vet receipt or letter from vet) that sterilization has taken place. Last Day does not warrant the health of the Rescue Cat.

****INITIAL HERE: _____** The Rescue Cat will NOT be declawed.**

- 4. Control.** The Rescue Cat will be kept as an indoor animal. It must be under control at all times while on the Adopter's property and is not to run loose off the Adopter's property. The Rescue Cat must use a cat specific harness & leash or be inside a cat carrier when not within the boundaries of the Adopter's property or inside a building.
- 5. Care.** The Adopter accepts full responsibility for maintaining a reasonable level of care for the Rescue Cat, including food, water, grooming, adequate sanitation, exercise, attention, safety, and shelter. The Rescue Cat will be treated with affection and kindness and never be subject to abuse, animal research, and in the case of the Rescue Cat, not be subject to cat fighting, or kept as an outdoor animal.
- 6. Reservation of Rights.** Last Day reserves the right to an ongoing review of this adoption and to follow-up on any complaints or reports to protect the welfare of the Rescue Cat.
- 7. Remedies Upon Default.** Should the Adopter breach any of the agreements contained in this contract or have misrepresented any facts to Last Day Dog Rescue to obtain the Rescue Cat, Last Day shall have the right to rescind this contract and demand return of the Rescue Cat. Should the Adopter fail to return the Rescue Cat, Last Day may, at its option, a) peaceably enter the Adopter's property to take possession of the Rescue Cat, or b) seek an order from a court of competent jurisdiction for return of the Rescue Cat and payment of damages and will retain the sum paid for the Rescue Cat pursuant to this agreement.
- 8. Attorney's Fees.** The Adopter agrees to pay actual attorney's fees and other costs incurred by Last Day to obtain the remedy available under Paragraph 7 above.
- 9. Severability.** If any provision of this Agreement is held illegal or unenforceable in a judicial proceeding, such provision shall be severed and shall be inoperative, and the remainder of this Agreement shall remain operative and binding on Last Day and Adopter.
- 10. Schedule A: **INITIAL HERE: _____**** The Adopter has signed Schedule A and understands that cats/children can be unpredictable and must ALWAYS be supervised when interacting.
- 11. Microchip:** Last Day microchips all their cats. A Last Day representative will add your name/contact info to the Rescue Cat's microchip registration. Notify Last Day of any moves so the microchip information can be updated. Microchip # _____

Tagging collar is not optional and MUST be done immediately. YOU MUST ESTABLISH YOUR CAT WITH A LICENSED VET WITHIN 2-4 WEEKS OF ADOPTION. Kittens will need to be followed up with vet per Kitten Addendum.

BY THE FOURTEENTH (14) DAY AFTER THE DATE THE ANIMAL IS STERILIZED** and if proof is provided by date specified above, I will be entitled to a refund of \$25.00. I also understand that if I do not have aforementioned animal sterilized or do not deliver the required proof of spay/neuter to Last Day Dog Rescue, Inc. within the time stated above, the **REFUND OF \$25.00 WILL BE FORFEITED**, and Last Day Dog Rescue, Inc. will then peaceably enter the Adopter's property to take possession of the Rescue Cat and seek an order from a court of competent jurisdiction for breach of contract. Failure to neuter/spay the Rescue Cat will also incur liquated damages of \$1000.00 unless determined by a vet to be detrimental.
